

PARTICIPATION REGULATIONS

"4th International Conference of Metals, Ceramics and Composites ICCMCC 2024"

September 8-11, 2024, Varna, Bulgaria

1. The Organizers of the 4th International Conference of Metals, Ceramics and Composites ICCMCC 2024 are the Polish Foundrymen's Association (STOP) and Institute of Metal Science, Equipment and Technology with Hydroaerodynamics Centre.
2. The condition for participation in the conference is registration via the on-line application form available on the conference website – <https://mcc.foundry-conference.com> in the REGISTRATION tab by July 1, 2024 (early registration) or July 31, 2024 (late registration).
3. Regular conference fee includes: all inclusive accommodation for 3 nights (8-11 September 2024), oral or poster presentation, book of abstracts (online), coffee breaks, publication of a full-length article in recommended journal
4. Conference fee doesn't includes: VAT tax, flight tickets
5. Payments should be made by bank transfer to the STOP account by July 14, 2024 for early registration, August 6th, 2024 for late registration, without any claim for a refund in the event of the absence of the person registered for the conference.
6. Applications sent after July 31st, 2024 will not be considered.
7. The condition for participation in the conference is that the full conference fee is credited to the STOP account by July 14, 2024 for early registration, August 6th, 2024 for late registration.
8. The participant agrees to the processing of his personal data by the Polish Foundrymen's Association. Information on the processing of personal data by the Association is available at: <https://stowarzyszenie-stop.pl/wp-content/uploads/2019/02/Information-regarding-personal-data-STOP.pdf>
9. The participant agrees to use and processing of his image, recorded in the form of photos taken during the conference. The permit in question entitles the Organizers to process images using any technique in all fields of use (in particular: print, Internet, press publication), indefinitely and without territorial limitation - only for information and promotional purposes of the conference.
10. Conditions for resignation:
 - a. Resignation is possible only in writing, by e-mail: mcc@foundry-conference.com.
 - b. No written resignation from a participant by July 31st, 2024, will result in charging the Participant with the total cost of participation in the conference.
 - c. Lack of full payment for participation is equal to resignation from participation in the conference.
 - d. It is allowed to change the person enlisted by August 31st, 2024, after informing the Organizers.

11. The Organizers reserve the right - in the event of circumstances beyond their control, in particular the introduction of restrictions related to the COVID-19 epidemic or caused by military operations to change the conference formula to a remote or hybrid (onsite + remote).
12. If the conference is organized in a remote or hybrid form, for reasons beyond the control of the Organizers, the Participant is not entitled to reimbursement of participation fees and the right to receive compensation.
